I, **THEODOR MERON**, President of the International Residual Mechanism for Criminal Tribunals (“Mechanism”);

**NOTING** the “Request for Appointment of Single Judge” filed by Radovan Karadžić (“Karadžić”) on 4 November 2013 in the case of *Prosecutor v. Radovan Karadžić*, Case No. MICT-13-55-R90.1 (“First Request”), by which he requests that I appoint a Single Judge to “consider whether to appoint an *amicus curiae* prosecutor to investigate possible contempt by former ICTY Prosecutor Carla Del Ponte” in the case of *Prosecutor v. Slobodan Milošević*, Case No. IT-02-54-T;<sup>1</sup>

**NOTING** the “Request for Appointment of Single Judge” filed by Karadžić on 4 November 2013 in the case of *Prosecutor v. Slobodan Milošević*, Case No. MICT-13-58-R90.1 (“Second Request”), by which he requests that I appoint a Single Judge to “consider whether to appoint an *amicus curiae* prosecutor to investigate possible contempt by former ICTY Prosecutor Carla Del Ponte” in the case of *Prosecutor v. Slobodan Milošević*, Case No. IT-02-54-T;<sup>2</sup>

**RECALLING** Article 12(1) of the Statute of the Mechanism;


**CONSIDERING** that it is appropriate to assign the First Request and the Second Request to a Single Judge;

**PURSUANT TO** Rules 23(A) of the Rules of Procedure and Evidence of the Mechanism,

**HEREBY ASSIGN** the First Request and the Second Request to Judge Bakone Justice Moloto as Single Judge.
