Statement of Gratién Kabiligi

I, Gratién Kabiligi, hereby declare under penalty of perjury that the following is true and correct:

1. I was the head of the G-3 bureau on the General Staff of the Rwandan Army from September 1993 to July 1994.

2. I have been acquitted at this Tribunal in December 2008.

3. I have been advised that at the trial of Joseph Nzirorera, Prosecution Witness UB has testified that I was present at a meeting at the Kigali prefecture office in late April 1994 at which Joseph Nzirorera attended and at which the prefet of Kigali, conseillers, and Interahamwe were present.¹

4. I never attended or heard of such a meeting.

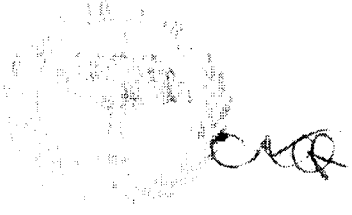

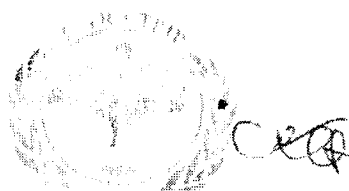
