

- 1 By its scheduling order dated 18 April 2007 the Appeal Chamber ordered that responses were to be filed no later than ten days from the date of filing of the initial brief.
2. The Registrar has now filed his submissions received by the defence by internet today.
It is a substantial document inviting careful response.
- 3 Counsel, David Hooper, will be leaving today for Dubai to assist in a course for Iraqi judges and will not be back in the United Kingdom until the 13th May. Andreas O'Shea is currently appearing before the Special Tribunal in Sierra Leone where there are significant difficulties communicating by email. Both counsel will be hampered by poor communication and research facilities.
4. For that reason the defence respectfully request the Appeal's Chamber to extend the time for response from May 14th (the first working day) to Thursday 17th – a modest extension of time for three days.
