**THE APPEALS CHAMBER** of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States Between 1 January and 31 December 1994 (“Tribunal”);

**NOTING** the Judgement rendered in this case by Trial Chamber III on 2 December 2008;<sup>1</sup>

**NOTING** the “Notice of Appeal”, “Defence Appellant’s Brief”, “Corrigendum to Defence Appellant’s Brief”, and the “Defence Appellant’s Reply Brief” filed by Simon Bikindi (“Appellant”) on 31 December 2008, 16 March 2009, 19 March 2009, and 11 May 2009, respectively, and the “Prosecutor’s Respondent’s Brief” filed by the Prosecution on 27 April 2009;

**NOTING**, further, the “Prosecutor’s Notice of Appeal” and the “Prosecutor’s Appellant’s Brief”, filed by the Prosecution on 31 December 2008 and 28 January 2009, respectively, and the “Defense Respondent’s Brief” filed by the Appellant on 20 February 2009;<sup>2</sup>

**CONSIDERING** that the filing of the briefs in these appeals is complete;

**PURSUANT** to Rule 114 of the Rules of Procedure and Evidence of the Tribunal;


