THE APPEALS CHAMBER of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States, between 1 January and 31 December 1994 (“Tribunal”);

NOTING the Judgement rendered in this case by Trial Chamber III of the Tribunal on 11 February 2010;

NOTING “Accused Tharcisse Muvunyi’s Notice of Appeal”, filed on 15 March 2010; “Accused Tharcisse Muvunyi’s Brief on Appeal”, filed on 31 May 2010; “Prosecutor’s Respondent’s Brief”, filed on 12 July 2010; and “Accused Tharcisse Muvunyi’s Reply to the Prosecutor’s Respondent’s Brief”, filed on 27 July 2010;

NOTING “Prosecutor’s Notice of Appeal”, filed on 15 March 2010; “Prosecutor’s Appellant’s Brief”, filed on 14 April 2010; “Accused Tharcisse Muvunyi’s Response to Prosecutor’s Appellant’s Brief”, filed on 14 May 2010; and “Prosecutor’s Brief in Reply”, filed on 24 May 2010;

CONSIDERING that the filing of the briefs in these appeals is complete;

PURSUANT to Rule 114 of the Rules of Procedure and Evidence of the Tribunal;
