THE APPEALS CHAMBER of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January and 31 December 1994 (“Appeals Chamber” and “Tribunal”, respectively);

NOTING the judgement pronounced in this case by Trial Chamber II of the Tribunal on 30 September 2011 and filed on 19 October 2011;¹

NOTING “Justin Mugenzi’s Notice of Appeal” and “Prosper Mugiraneza’s Notice of Appeal”, filed on 21 November 2011;² “Justin Mugenzi’s Appeal Brief” and “Prosper Mugiraneza’s Appellate Brief”, filed on 20 February 2012; “Prosecutor’s Brief in Response to Justin Mugenzi and Prosper Mugiraneza’s Appeals”, filed on 30 April 2012; and “Justin Mugenzi’s Reply Brief” and “Prosper Mugiraneza’s Reply to the Prosecutor’s Appellate Brief”, filed on 15 May 2012;

CONSIDERING that the filing of the briefs in this case is complete;
