The Prosecution does not oppose Karadžić's motion<sup>1</sup> for reclassification or the issuance of a public redacted version of a decision rendered by the Single Judge on 5 January 2017 ("Decision")<sup>2</sup> so long as it would not reveal confidential information about protected witnesses, ongoing investigations, or other sensitive matters. As the Prosecution was not a party to the proceedings and has no access to the Decision, it is unable to provide submissions in relation to the specific contents of the Decision, or propose appropriate redactions. Input in this regard should be sought, as appropriate, from affected parties.
